After a brief lunch break, the members held a discussion around the Coordinated Entry Project, ranking, interpretations of components on the scoring sheets, and evaluation of the projects. The following are notes from that discussion:

- A. After each Ranking Committee member provided their scores, a lengthy discussion ensued about the components listed on the scoring sheets for both the renewal and new project scoring sheets. Along with discussion concerning the Annual Performance Reports submitted with the applications.
- B. The Ranking Committee reviewed the CoC Membership Priorities and Scoring Outcomes. The Committee reaffirmed that it would rank projects according to the priorities established by the membership and listed in the Macomb CoC FY2018 Program Competition Process documents. Therefore, the Committee ranked as follows:
  - 1. Two CoC Infrastructure Projects; HMIS 1 & HMIS 2 Macomb Homeless Coalition. Tier 1.
  - 2. Three PSH Project; MLAP 1, MCHLAP 1 & MLAP 6 Community Housing Network. Tier 1.
  - 3. One Youth Project; FYI TLP Family Youth Interventions. The membership provided a caveat to ensure special projects are assured services. In the application, the special population is unaccompanied youth. Tier 1.
  - 4. Four PSH projects; MCHLAP 6, MCHLAP 8, MCHLAP 5 & MLAP 7 Community Housing Network. Tier 1.
  - 5. One Family RRH project; Macomb CMH RRH Macomb County Community Mental Health. Split between Tier 1 and Tier 2.
  - 6. One PSH project; MLAP 2 Community Housing Network. Tier 2
  - 7. One Family RRH project: Project Home RRH Perfecting Community Development Corporation. Tier 2.
  - 8. One DV Bonus project: DV Bonus RRH Turning Point. Tier 2.
  - 9. One CoC Infrastructure project: CE Bonus Project Macomb Homeless Coalition. Tier 1.
  - A Bonus Project submission from Family Youth Interventions was excluded from consideration due to the rating of proposed plan not meeting threshold score for new projects, questionable fidelity to housing first approach, and proposed budget..

Next steps: 1. Prepare rejection letters for Family Youth Intervention Bonus Project. Prepare email to applicants with projects that will be part of the CoC submission regarding completing their project applications in e-snaps. 4. Rankings and ranking
